Eric Hitchcock gave the Foundation report after the recess. He encouraged all to assist in the areas they are in for the CFC. He also encouraged all to give to the Association Foundation instead of the Wounded Warriors Program. This will go to the 173rd wounded warriors. He said the WWP have a 75 million dollar budget of which only 35 million goes to wounded warriors. The Foundation has its treasurer and accounts in Houston. Eric told us he is trying to track our amputees to see if they need assistance.

Eldon then talked about the Memorial Foundation. He had attended their function the week before the reunion and said there were 250 or more people in attendance.

Lester asked for us, the Association, to get the tax information out for all the chapters. So all chapters will not have extra work to do, but it all be under the Association. CH 1 said they have just become a 501-C19 organization. This is for veterans organizations. Jerry Cooper then spoke. He said the C19's must file an IRS Form 990 yearly. We need to obtain corporate sponsors. We should start using TechSoup.org for computer assistance. He also told of the different two types of organizations which should benefit the Association and the chapters. He also said we need to keep all drawings under \$600. Anything over that we must file an IRS form for and that the Special Forces were just audited by the IRS

and almost lost all their tax free status because they had not done this. The SF guys are working with the IRS to get past that. We need to take a look at how we do business in order to keep the IRS off us.

The Bradley matter then came up. Terry presented the letter to the Board that Jim had sent in from the reunion in Las Vegas. There was much discussion and consternation on this matter. Trudell then gave a talk about this and said he will look at legal matters involved and get back with the BOD with a recommendation. All agreed we need to change the bylaws to better allow the BOD to take action against chapters that do not follow the by-laws. All agreed the report from the chapter that just held the reunion needs to be turned in. That is regardless if any money was made from the reunion or not. The financial report should be submitted as per the by-laws. It was brought up to censor Jim. Trudell made the motion, it was seconded by Sam and passed. Frank said he should also be censured as he was an assistant in hosting the Las Vegas reunion.

A motion was then made to adjourn. It passed.
