Copies of the Treasurer's report were distributed and told they are on-line. Eldon Meade made a motion to accept them, this was seconded by Terry Gannon and passed with no dissenting votes.

Bob Cockerill gave a report for Australia and New Zealand. The Australian government finally gave the 1st RAR the Cross of Gallantry for their service with the 173rd in Vietnam. All the chapters were active and doing well (CH 11, CH 19, CH 23, CH 27). Chapter 11 had a meeting 900 kilometers out of Sydney to broaden their membership. They have over 400 members in Melbourne that were 173rd members. John Deazley, New Zealand, agreed with Bob. The 1st RAR will have its "official" 50th Anniversary in July of this year. That is when they will be presented the Cross of Gallantry.

Frank Marcantonio then gave an update from the active Brigade. They are looking forward to hosting the Association for a gathering in Italy in 2017. He wanted all to start planning so they can be there.

We, as the Association, are incorporated. However, some of the individual chapters have their

- 2. Each Chapter needs to re-look at their by-laws and determine if they wish to get under the Association. This is for using the Association's tax identification number and for the Association filing a consolidated annual IRS Form 990 report for all of the Chapters. Each Chapter should fall under the Association. Why some Chapters have chosen not to, is another issue. But by complying, they will have to abide by the tax requirements to do so. This motion was made by Bob Madden and seconded by Eldon Meade. It was passed with no dissenting votes.
- 3. The subject of adding a Webmaster to the appointed Association positions was brought up. The motion to do this was made by James McSorley and seconded by Lester Yeargin. It passed with no dissenting votes. Eldon Meade brought out that it did not need to be in the by-laws as the appointed positions were not specified in the by-laws.
- 4. Frank Marcantonio brought up the issue of changing the by-laws for the Sigholtz award. The Brigade would prefer this be given to a junior officer. The Brigade has a Sky Soldier of the year and an NCO of the year, both of which represent the US Army in Europe to the US Army as a whole. This will be looked into by a committee and be brought to the Board at the 2016 Mid-Winter Conference next January.

The motion to adjourn was made by Lester Yeargin and seconded by Francis Henton. It was passed.
