Who's Packing Your 'Chute'

Out of all the parachute jumps I made in the Army (three in Vietnam) I never once met the men who packed my 'chutes. The riggers did their jobs and when it came time to jump we were issued the T-10's, and off we went to jump from perfectly good airplanes. We simply trusted that the parachutes on out backs were property packed and would keep us from certain death. It was the epitome of faith.

Not long ago I heard the story of Charles Plumb, a Navy pilot who was shot down over North Vietnam. Many years after the war (where he spent six years in a communist prison) Plumb met the man who packed his 'chute. They stumbled upon each other in a restaurant, and the conversation went like this:

"You're Plumb! You flew jet fighters in Vietnam from the aircraft carrier Kitty Hawk. You were shot down!"

"How in the world did you know that?" asked Plumb.

"I packed your parachute," the man replied.

Plumb gasped in surprise and gratitude. The man pumped his hand and said, "I guess it worked!"

Plumb assured him, "It sure did. If your 'chute hadn't worked, I wouldn't be here today..."

Like Plumb, we paratroopers would not be here today had the riggers working behind the scenes not done their jobs. Even though we volunteered to jump from planes and Plumb did not, the end result would have been the same for all of us.

We live in a world that offers nearly everything imaginable to make life comfortable. Because of this, it is easy to lose track of who is packing our 'chutes. Consciously, or unconsciously, we turn our equipment over to unknown forces every day to be filled with something. And let me assure you, it always gets packed—it never stays empty. Do you know what goes

in yours on a daily basis? Do you inspect it? Do you check to see if the "riggers" have the right stuff to put in there? Are they things that will make a difference in whether you survive in the end or not?

One of the wonderful aspects of God is that in His plan for you He gave you the gift of choice. If there is one thing He will never alter or tamper with, it is your freewill to choose what goes in your 'chute. You may think that what you allow the world to put in it will help you survive the eventualities of this life. Perhaps in all outward appearances it looks like it will. But you and I both know better than that. We also know that no one, in spite of all the advancements in technology, has ever figured out the mystery of what lies beyond this life. So it is faith that we rely on.

It comes down to getting on the plane with a 'chute on our back that was either packed by someone with flimsy human credentials—or by God. If it is God, through a relationship with His son, Jesus Christ, whom we put our trust in, then we have a lifetime guarantee that our lives will be spared. It really is that simple.

It's your choice ... and a volunteer army.

At the Reunion in Fayetteville, General Deane told of efforts underway to get appropriate recognition for the actions of a Skysoldier Medic named Keith Campbell, assigned to HHC/1/503, and attached to A/1/503. Campbell voluntarily went to help B/1/503 which was in a fierce fire fight in War Zone D that day, February 8, 1967.

Sp4 Edward D. Torres was wounded and eventually recovered by members of Bravo Co. The key events are those between the wounding and the final rescue.

General Deane wants to locate anyone who was in or near that fire fight. Some have been found. Captain John Wilson, C.O. of B/1/503 has been found and has provided valuable assistance. Paul Eggie, Bill Everhart, and Ken Rypka, another medic have been found and have provided important insights and valuable statements. Probably the most crucial find has been Torres, himself. Henry Galindo went from address to address of possible locations until he found Torres.

The names listed at the top of this article are potentially valuable sources of information. If any of these names ring a bell, or refresh your memory about a fire fight that occurred on February 8, 1967, please contact General Deane through the Society address.






LARRY S. PIERCE MEDAL OF HONOR 173d AIRBORNE BRIGADE

The issue of unit markers for each Airborne Unit at the Museum entrance has been decided. We of the 173d continue to lead the way. We are the first unit to contract for the marker which is to be made of white granite and emplaced at the main entrance of the museum. At the time of our 1999 reunion, 12 other units had contracted for a marker as well as one for the Test Platoon. The cost of each one which includes total manufacture plus emplacement is \$3000.00. This money as well as the cost of MH pavers will come out of the Museum Fund which was raised by direct solicitation through our Pathfinder Club. Through Loren Storjohann's almost magical management of our Pathfinder funds, we have retired our \$50,000,00 debt for the 173d Vietnam War Diorama and still have funds to pay for the 173d Marker and a Paver for each of our MH recipients. We all owe Loren a great debt for stretching our dollars as far as he has.

If everything goes as planned, my next report to you will cover the grand opening of our museum in May of 2000. I wish to point out to you that this place will be your theater to the future. This is where you can create your legacy; the place you can send your children and your grandchildren and all those others who follow along behind you to learn of your accomplishments; the place where all Americans can see and learn who you and other Airborne Soldiers were and what you accomplished. It will be a monument that praises your accomplishments and sanctifies your sacrifices. In short, this is your story. How well it is told is in direct proportion to how well we support the effort. I appeal to all of you to once again prove to all that the 173D LEADS THE WAY.
